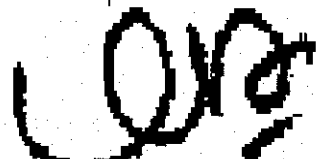


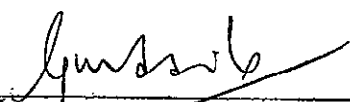

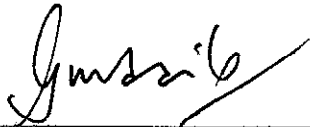

This Writ may not be served more than 6 calendar months after the above date unless renewed by Order of Court.

The Defendant(s) may enter an appearance either personally or by a solicitor at the Registry of the Subordinate Courts.

Note: If the Defendant(s) enter an appearance, then, unless a summons for judgment is served on them in the meantime, they must also serve a defence on the solicitor for the Plaintiff(s) within 14 days after the last day of the time limited for entering an appearance, otherwise judgment may be entered against them without further notice.

STATEMENT OF CLAIM

1. By an Agreement in writing dated the 5th day of May, 2000 (hereinafter referred to as "the said agreement") made between the Plaintiffs and the Defendants, the Defendants leased from the Plaintiffs a flight simulator by the name of "AUDREY" (hereinafter referred to as "AUDREY") for an initial period of two (2) months with an option to renew the same for a further period of two (2) months.
2. It was an express term of the said agreement inter alia that the Defendants shall pay the Plaintiffs a sum of US\$2,000.00 per month commencing from 1st July, 2002, for the lease of AUDREY. Additionally, the Plaintiffs pursuant to the said agreement had incurred an additional sum of US\$4,500.00 in respect of labour and service charges rendered by the Plaintiffs to the Defendants, full particulars exceeding three (3) folios had already rendered to the Defendants by the Plaintiffs.
3. It was a further term of the said agreement that the Defendants would act as exclusive agent of the Plaintiffs to facilitate the sale of AUDREY to any interested third party within thirty (30) days after the expiry of the lease period for a sale price that was agreed and fixed at US\$20,000.00. The Plaintiffs in accordance with the said agreement provided the Defendants with AUDREY and the Defendants in turn provided the AUDREY to a third party in China.
4. The Plaintiffs shall refer to the said agreement for its full terms and effects at the trial of the matter.
5. In breach of the said agreement, the Defendants had failed, neglected and refused to return AUDREY to the Plaintiffs and had wrongfully breached the said agreement and the Plaintiffs had thereby suffered damages and had been put to loss and expense.

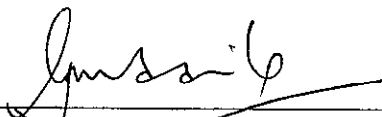

6. By a solicitors letter dated 18th July, 2002, the Plaintiffs demanded that the sum of US\$72,500.00 and the Defendants have till date failed to settle the said sum.

7. And the Plaintiffs claim :-

- (a) the said sum of US\$48,000.00 and US\$4,500.00 under paragraph 2 above;
- (b) the said sum of US\$20,000.00 under paragraph 3 above;
- (c) interest thereon at the rate of 6% per annum from the date hereof until Judgment or payment;
- (d) costs;
- (e) further and other relief this Honourable Court may deem fit.
